In continuation to this office advertisement on dated 05.06.2021 for filling up of **01 (One)** post of **Driver (Class-III) (Non-Gazetted) (Unreserved)** on **daily wages basis**, Department of Electrical Inspectorate, Himachal Pradesh again invites applications for filling up 1 Post of Driver on daily wages @ of Rs.336/- per day under Electrical Inspectorate strictly as per Recruitment & Promotion Rules and selection procedure as notified by Government of H.P. vide notification No.Per (AP)-C-A(3)-4/2010-Loose on 16.09.2021.

**NOTE: -** The candidates who have already applied for the above recruitment for filling up of said **01 (One)** Post of Driver on Daily Wage Basis as per above referred advertisement, need not to apply again as their earlier applications shall be entertained. **Terms and conditions:**

**1. Education and other qualification**

- 1.1 Essential: (i) Matric Pass from a recognized Board of School Education.  
(ii) Must possess valid driving license for plying of heavy/ light vehicles in hilly terrain.
- 1.2 Desirable: Knowledge of customs, manners and dialects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the Pradesh.
- 1.3 The candidate should be a Bonafide Himachali.

**2. Age Limit:** The age of the applicant should be between 18 and 45 years as on 01.01.2021. The relaxation in upper age limit is permissible upto 5 years in case of SC applicant as per instructions of the Government of Himachal Pradesh.

**3. How to Apply:** The desirous and eligible candidates applying for the post of Driver may apply on the prescribed application form (also available on the Department official Website <http://ei.hp.gov.in/>) alongwith attested copies of all relevant testimonials/ documents so as to show their age/ qualification/ experience etc. The applications should be addressed to The Chief Electrical Inspector, Himachal Pradesh, Block No. 29, S.D.A. 
6. **Mode of Selection:** - Selection for appointment to the post shall be made on the basis of driving/ skill test of 85 marks conducted by the Committee, formed as per above cited notification of 16.09.2021 and followed by evaluation based on the parameters as specified in **Appendix-I**.

**Passing of practical test shall be mandatory.** Test shall be based upon general control of vehicle, Track Driving test. Knowledge of Traffic signals, Parking on service dug (parking facing uphill, downhill), forward & reverse, etc.

The documents shown at Sr. No (ii) to (ix) of **Appendix-I** should be issued by the respective competent authorities as per **Appendix-II**. The Appendix-I&II are available on departmental website i.e. <http://ei.hp.gov.in/>.

**Any changes in selection process notified at latter stage by the Government i.e. upto completion of selection, the test/ evaluation shall be conducted accordingly.**

7. **Evaluation:** -The scrutiny, verification and evaluation of documents / certificates shall be made by constituting a Committee of the departmental officers on the basis of marks obtained in the Driving Test /practical test. The date for evaluation of documents and driving skill test shall be intimated separately.

## Driving Skill Test

Test shall be based upon general control of vehicle, Track Driving test, Knowledge of Traffic signal, Parking on service dug (parking facing uphill, downhill), forward & reverse, etc.

- i) Weightage for the minimum educational qualification, prescribed in the Recruitment & Promotion Rules.  
{Percentage of marks obtained in the educational qualification would be multiplied by 0.02 For example, an individual has secured 50 % marks in the required educational qualification, he/she will be allowed 1 marks (50x0.02) =2 (two)}
- ii) Belonging to notified Backward Area or Panchayat, as the case may be.

3. The candidates must possess requisite essential qualification prescribed for the post on or before the last day of receiving the application as per mentioned in the advertisement in newspaper.
4. The application should be sent under registered cover/ speed post addressed to the Chief Electrical Inspector, Block 29, SDA Complex, Kasumpti, Shimla-09.
