ORDER

Authorization of Chartered Electrical Safety Engineers

As per Department of MPP & Power notification No.MPP-F(5)-22/2013-II dated 06.01.2020 and subsequent notification on dated 05.10.2020 this department had advertised accordingly in two leading newspapers and invited applications from eligible candidates for authorization of Chartered Electrical Safety Engineers in accordance with regulation 5A of Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2010.

Interview of eligible candidates was conducted on dated 28.07.2021 and following candidates are approved as Chartered Electrical Safety Engineer to assist the owner or supplier or consumer of electrical installations for the purpose of **self-certification** up to the **notified voltage of 415 volts** under regulation 30 and regulation 43 of Central Electricity Authority (Measures relating to Safety and Electric Supply), Regulations, 2010, provided those installations are not be covered under section 54 of Electricity Act, 2003.



Note: The authorization for CESE will be subjected to following terms and conditions as per MPP and Power's Notification No.MPP-F(5)-22/2013-II dated 06.01.2020.: -

1. CESE shall carry out recommended tests as per the relevant Regulation and Standards.
2. CESE shall test electrical installations & keep a record thereof in **Form-I/ Form-II** of Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2010, as the case may be and submit the same along with photographs/ video of the apparatus tested to the respective office of the Chief Electrical Inspector (CEI) *within seven working days* to the notice to the owner and the office of Chief Electrical Inspector (CEI) *within the period of 48 hours* from the date of testing.
3. a) Fee/Charges for testing of electrical installation in a single premise upto notified voltage under **Regulation 43** of Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2010 is **Rs. 5000/-**.
b) Fee/Charges for Periodic Testing of electrical installation in a single premise up to notified voltage under **Regulation 30** of Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2010, is **Rs. 3000/-**.

N.B.: *Fees to be levied by the Chartered Electrical Safety Engineer from the Utilities shall be received in the modes other than cash.*

4. The authorization of a Chartered Electrical Safety Engineer shall be liable to be suspended or cancelled if CESE are found to be indulging in willful negligence, malpractices, misuse or any other activities affecting directly and in-directly the safety of electrical installations.
5. The authorization of a Chartered Electrical Safety Engineer shall be initially for the period of **three years** and the authorization shall be extended for a period of additional **two years** at a time by the office of the Chief Electrical Inspector based on the performances of Chartered Electrical Safety Engineer. **However, the authorization will cease automatically on his/her attaining the age of 65 Years.**
6. In case of any dispute arising between Chartered Electrical Safety Engineer and owner or supplier or consumer on the inspection, the decision of the Electrical Inspector, Himachal Pradesh shall prevail.
7. Any electrical installation which have been checked/ tested by the Chartered Electrical Safety Engineers could be inspected / revisited by the Chief Electrical Inspector in case he/ she is not satisfied with the check/ testing carried out by Chartered Electrical Safety Engineers.
8. The testing equipment (as mentioned in Annexure-I) used by the Chartered Electrical Safety Engineer shall be calibrated at any National Accreditation Board for Testing and calibration Laboratories at least once in every two years.


