Education and other qualification

- 1.1 Essential: (i) Matric Pass from a recognized Board of School Education.
 - (ii) Must possess valid driving license for plying of heavy/ light vehicles in hilly terrain
- 1.2 Desirable: Knowledge of customs, manners and dialects of Himachal Pradesh and suitabilityfor appointment in the peculiar conditions prevailing in the Pradesh.
- 1.3 The candidate should be a Bonafide Himachali.
- 2. Age Limit: The age of the applicant should be between 18 and 45 years as on 01.01.2021. The relaxation in upper age limit is permissible upto 5 years in case of SC applicant as per instructions of the Government of Himachal Pradesh.
- 3.
