3.	Medium Industrial Consumer (with connected demand between 51 to 100 KVA)	3% for five years and thereafter as per applicable prevailing rate
4.	Small Industrics Consumers (with connected demand upto 50 KVA)	1% for five years and thereafter as per applicable prevailing rate
5.	All Industrial consumers including EHT category consumers which employ more than 300 H:machalies	1% for five years and thereafter ED rate would be as per rates applicable under respective category
