The Governor, Himachal Pradesh is pleased to order amendment in this Department notification No.MPP-F(6)-1/2023 dated 1.9.2023, and to revise the rates of Electricity Duty in respect of the following categories of Consumers, in line with the Section 11(2) of the HP Electricity Duty Act,2009, with immediate effect, in the public interest:-

Sr. No.	Consumer Category	Existing Rate Electricity Duty	Revised Rates Electricity Duty
1.	Non domestic non commercial consumers (connected load more than 20 KW)	5%	4.5%
2.	Small Industrial Consumers	11%	3%
3.	Medium Industrial Consumers	17%	10.5%
4.	Large Industrial Consumers (above 100 KVA) except: (iii) cement industries, Mines Quarry whose Electricity Duty rates will be as notified vide Notification No.MPP-F(6)-1/2023 dated 1.9.2023. (iv) Stone Crusher whose Electricity rates will be as notified vide Notification No.MPP-F(2)-1/2024 dated 18.1.2024.	19%	16.5%

Further, it is clarified that the industries, which have been granted benefits/concessions in Electricity Duty under the Himachal Pradesh Industrial Investment Policy, 2019 shall continue to avail the benefit/concession under the said policy for the admissible period.

In exercise of the power conferred by Section 11(2) of the Himachal Pradesh Electricity (Duty) Act,2009, the Governor, Himachal Pradesh is pleased to order revision of the rates of Electricity Duty levied under Section 3 of the Himachal Pradesh Electricity(Duty) Act,2009 for the following category of consumers with immediate effect in the public interest, as under:-

Sr. No.	Consumer Category	Existing Rate Electricity Duty	Revised Rates Electricity Duty
1.	Large Industrial Consumers (above 100 KVA) availing power at 11kV and 22kV except: (i) Cement Industries, Mines Quarry whose Electricity Duty rates will be as notified vide Notification No.MPP-F(6)-1/2023 dated 1.9.2023. (ii) Stone Crusher whose Electricity rates will be as notified vide Notification No.MPP-F(2)-1/2024 dated 18.1.2024.	19%	10%

Further, it is clarified that the industries, which have been granted benefits/concessions in Electricity Duty under the Himachal Pradesh Industrial Investment Policy, 2019 shall continue to avail the benefit/concession under the said policy for the admissible period.
