NOTIFICATION

Whereas, the Central Electricity Authority constituted under section 70 of the Electricity Act, 2003, in exercise of powers conferred under section 177, has framed regulations providing for measures relating to Safety and Electric Supply namely the Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2010 (hereinafter referred to as "CEA Regulations").

And whereas, in terms of the provisions under sub-section (1) of section 162 of the Act ibid read with clause (zka) of regulation 2 of "CEA Regulations" the appropriate Government is empowered to specify the notified voltage for the purpose of self certification under regulation 30 and regulation 43 of the said regulations.

Now, therefore, in exercise of the powers conferred under sub-section (1) of section 162 of the Act ibid read with clause (zka) of regulation 2 of "CEA Regulations", the Governor of Himachal Pradesh is pleased to specify that the notified voltage for the purpose of self certification under regulation 30 and regulation 43 of the "CEA Regulations" shall be 415 volt (LT).
