**NOTIFICATION**

Whereas, the Central Electricity Authority constituted under section 70 of the Electricity Act, 2003, in exercise of powers conferred under section 177, has framed regulations providing for measures relating to Safety and Electricity Supply namely the Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2010 (hereinafter referred to as "CEA Regulations");

And whereas, in terms of the provisions under sub-section (1) of section 162 of the Act ibid read with Regulation 32 of "CEA Regulations" the appropriate Government is empowered to notify the capacity above which the generating units will be required to be inspected by the Electrical Inspectors in the State.


Now, therefore, in exercise of the powers conferred under sub-section (1) of section 162 of the Act ibid read with regulation 32 of "CEA Regulations", the Governor of Himachal Pradesh is pleased to notify the capacity above which generating units will be required to be inspected by the Electrical Inspectors before commissioning for the installations of generating stations or generating units ( including generating units producing electricity from renewable source of energy) as under:-

i)	Upto 50 KW	Self Certification
ii)	Above 50 KW	Electrical Inspector
