- 1. He will be paid a fixed contractual amount @ Rs .12360/- per month.
- 2. The Service of the contract appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance / conduct of the contract appointee is not found satisfactory. In case the contract appointee is not satisfied with the termination order issued by the Appointing Authority, he may prefer an appeal before the Appellate Authority who shall be higher in rank to the Appointing Authority, within a period of 45 days, from the date on which a copy of termination orders is delivered.
- 3. He will be entitled for one day's casual leave after putting in one month service. However, he will also be entitled for 10 days Medical Leave and 05 days Special Leave. He shall not be entitles for Medical reimbursement and LTC, etc. No leave of any kind except above is admissible to him.
- 4. Unauthorized absence from duties without approval of the controlling officer shall automatically lead to the termination of the contract agreement. However, in exceptional cases where the circumstances for un-authorized absence from duty were beyond their control on medical grounds, such period shall not be excluded while considering their control on medical grounds, such period shall not be excluded while considering their case for regularization but the incumbent shall have to intimate the controlling authority in this regard well in time. However, he shall not be entitled for contractual amount for this period of absence from duty.

- 5. He will submit a certificate of his fitness from the (CMO) District Hospital.
- 6. He will be entitled to TA/DA, if required to go on tour in connection with the official duties, at the same rate as applicable to regular counterpart officials at the minimum of pay scale.
- 7. Provisions of service rules like FR, SR, Leave Rules, GPF Rules, Pension Rules & Conduct Rules, etc. as are applicable in case regular employees will not be applicable in his case.
- 8. No travelling allowance will be paid to them for joining duties in Himachal Pradesh Electrical Inspectorate, Headquarter Office Shimla-171009.
- 9. He shall have to produce an affidavit to the effect that there is no court case/criminal/vigilance or appeal thereof pending for adjudication in any Court of Law in or outside the State of Himachal Pradesh against him.
- 10. In case, the contract appointee do not report for duty within the stipulated time period to the allotted station or brought outside influence for change of station, in that event the offer of appointment will stand automatically cancelled.
- 11. In rare and exceptional circumstances if a contractual employee is transferred to another station / cadre/ establishment on his own request with the approval of the competent authority, he shall be treated as fresh appointee in the new station/cadre/establishment and the services rendered on contract basis in the earlier cadre/ establishment on appointment / transfer to regularization purposes and for any other financial benefits. The contract appointee will be treated as fresh appointee for all intents and purposes.
- 12. The services of the incumbent appointed on contract basis will be regularized once in a year as per provisions of instructions issued by the Department of Personal vide letter No. PER(AP)-C-B(2)/2015, dated 02.12.2023 and any amendment issued from time to time, in future.
